### **1 Minutes**

The Minutes of the Meeting held on 18 April 2012 were agreed as a correct record and signed by the Chairman.

### **2 Declarations of Interest**

### **3 Revitalising Markets within County Durham Key Decision NH/06/11**

The Cabinet considered a joint report of the Corporate Director, Neighbourhood Services, and Corporate Director, Regeneration and Economic Development that presented the findings of the County Durham market review and which sought approval of the draft strategy for 'Revitalising Markets' within County Durham' for public consultation, and options for the future management and operation of markets across the county for further consideration (for copy see file of Minutes).
