The Leader confirmed the arrangements relating to the public question and answer session prior to every ordinary Cabinet meeting, which in addition to taking questions from members of the public, would also receive questions from the public made through the AAPs. Each AAP would get an opportunity to pose questions to Cabinet throughout the year on a rota basis.

1 Minutes

The minutes of the meeting held on 17 July 2013 were confirmed as a correct record and signed by the Chairman.

2 Declarations of interest

3 Review of School Crossing Patrol Service

Key Decision: NS/20/13

The Cabinet considered a report of the Corporate Director, Neighbourhood Services which summarised a review of the School Crossing Patrol (SCP) Service and recommended the removal of lunchtime provision where it is known that children no longer use the crossing facilities during the lunchtime period. The report also recommended that the existing SCP policy, agreed following a review of the SCP service in 2008, is retained (for copy see file of minutes).

5 Welfare reform update and review of Local Council Tax Support Scheme
Key Decision: CORP/R/13/03

The Cabinet considered a joint report of the Assistant Chief Executive, Corporate Director, Resources and Corporate Director, Regeneration and Economic development which updated Cabinet on recent policy developments relating to the government's welfare reforms, the council's response and the expected impact on the county. The report also considered a review of the council's Local Council Tax Support Scheme and the requirement to agree the council's approach to Local Council Tax Support for 2014/15 as well as an early operational review of the Welfare Assistance Scheme and the Discretionary Housing Payments policy, which had been in place since 1 April 2013 (for copy see file of minutes).

Members discussed at length the issues relating to the welfare reform agenda, and were extremely concerned at the effect on County Durham with research showing that the county would lose £188m from its economy due to the changes, and the loss per adult was significantly more than the average loss. The measures put in place would continue to be monitored and the implications of the agenda would be responded to as required.

Councillor Wilkes who in welcoming the report asked for assistance for those residents in Finchale Abbey who were just outside of the boundaries of the current plan. Councillor J Brown advised that BT Open Reach believe they had this covered, and although Finchale was outside the intervention area the Authority would continue to try and resolve this as they are committed to getting superfast broadband to as many properties as possible.
