### **Purpose of the Report**

- 1. The regeneration masterplans for Newton Aycliffe and Peterlee provide a detailed programme of activity that can be undertaken for the towns over the next 3-5 years to ensure future sustainability through investment and marketing of the towns' key development opportunities.
- 2. They provide the strategic context to delivery and seek to establish key principles to help co-ordinate and guide this activity.

### Background

#### Summaries

- 3. **Newton Aycliffe** has established itself as a major regional employment centre and an attractive place to live close to its own and other work opportunities. The location of Hitachi in the town and opportunities to feed into both Nissan's 'just in time' supply chain and Tees Valley offshore and process industries have created a regionally significant employment base. Housing has grown from its initial post war new town social housing roots to offer a greater range of private housing. A partnership is working to implement a phased improvement of the town centre.
- 4. **Peterlee** has also developed from its new town origins both as an employment and residential centre. Good transport links have enabled the growth of the business quarter to the west of the town to grow using employment zone status. Additional housing has broadened the range and size of housing available. The two secondary schools and East Durham College have moved into purpose built new buildings. Further housing growth is allowed for within the County Durham Plan and a current approval will substantially deliver this allocation. There are significant environmental benefits from the maturing new town layout and

close proximity of the Heritage Coast and Castle Eden. Tackling the decline and reuse of the North East Industrial Estate remains a priority. Two supermarket permissions have yet to be taken through to implementation and will impact substantially on the nature of the town centre depending on which options emerge. The town centre itself remains underprovided in relation to range of retail and leisure opportunities, with access needing improvement and issues with attractiveness for users.

- 5. The masterplans articulate the County Council's desire to stimulate regeneration and economic growth and to help to guide investment focussing on enhancing the development opportunities and the potential of the town.
- 6. The key drivers for delivery of the masterplans are:
  - Establishing a clear set of priority projects together with a realistic delivery plan which reflects both market demand, investor appetite and availability of sources of finance;
  - Promoting the diversification of the local economy and employment growth, led by the private sector;
  - Providing sustainable and vibrant town centres with a focus on deliverability, creating key opportunities for change by redevelopment, development or refurbishment of land and premises;
  - Consolidating the population base and improving the balance and mix of the housing offer which will in turn help to underpin a sustainable local economy, retaining young people whilst providing for an increasing proportion of elderly residents.
- 7. There are a range of development opportunities to be promoted in the towns and to provide the necessary conditions for a sustainable and competitive town centre. Key areas for council support are as follows:

### 7.1.1. Newton Aycliffe

- Ensuring the successful development for **Hitachi** and **Merchant Place** and seeking to double the number of jobs in the supply chain
- Ensuring strategic land allocation to support economic growth on Aycliffe Business Park
- Offering a robust **programme of support for businesses** through Business Durham and Economic Development, in partnership with other key stakeholders.
- Ensuring that allocation for **future housing development** is agreed through the Local Plan including strategic sites;

- Facilitation as land owner and providing business support through partnership to deliver Aycliffe Shopping Centre Masterplan. Reviewing delivery of services in the town centre to improve service delivery.
- Including the longer term County Durham Plan proposals, the anticipated public investment in the town is £16 million with the potential to generate up to £224 million in private investment over the next 30 years.

#### 7.1.2. Peterlee

- The Council will work with private sector partners to continue to **deliver a vibrant town centre**:
- The Council will endeavour to work with existing businesses, potential funders, developers and prospective inward investment companies to ensure that Peterlee enhances its supply of business properties in order to provide for wealth and job creation;
- Sites are proposed that would provide residential development. Additional housing will help the vitality and viability of the town and the Council will continue to work with the development industry, Registered Providers and other interested parties to deliver the new homes that Peterlee requires; and
- Key infrastructure support will improve the vitality of the town and increase opportunity for further development. The council will support the creation of a new railway halt at Horden and work with health providers to encourage improvements in provision in Peterlee and Horden.
- Including the longer term County Durham Plan proposals and current and recent projects, the anticipated public investment in the town is £95 million (including recent £72 million for new schools and college buildings) with the potential to generate up to £167 million in private investment over the next 30 years.
- 8. Consultation on the preparation of this Masterplan has been undertaken with a range of local stakeholders including the AAP Forums and Town and Parish Councils.

#### **Recommendations and reasons**

9. The Masterplans for Newton Aycliffe and Peterlee will help plan, coordinate, and deliver regeneration activity over the next 3-5 years.

It is recommended that the report and masterplans be approved by (a) Cabinet.
