Review of Polling Districts and Polling Places

Purpose of the Report

1. To present the draft review of polling districts and places to the Council for approval.

Background

- 2. Under Section18, the Representation of the People Act 1983, every constituency shall be divided into polling districts and there should be a polling place designated for each polling district.
- 3. It is the duty of the Council to divide its area into polling districts for the purpose of Parliamentary Elections and to designate the polling places for those districts. It is also the duty of the Council to keep the polling districts polling places under review in accordance with the following rules:-
 - The Council shall exercise its powers with a view to giving all electors such reasonable facilities for voting as is practicable in the circumstances (and in particular, they shall, so far as is reasonably practicable, designate as polling places, only places which are accessible to electors who are disabled):
 - Each parish community shall, in the absence of special circumstances, be a separate polling district or districts;
 - The polling place for any polling district shall be an area in that district, except where special circumstances make it desirable to designate an area wholly or partly outside the polling district, and shall be small enough to indicate to electors in different parts of the polling district how they will be able to reach that stage; and
 - A polling place need not be designated for any polling district, if the size and other circumstances of the district are such that the situation of the polling stations does not materially affect the convenience of the electors or body.

- 4. Attached at Appendix 2 is the draft review of polling districts and polling places for submission to Council.
- 5. This draft is being produced after consultation exercises which lasted from 1 July to 29 August 2014. The Returning Officer consulted a number of groups and individuals including:-
 - Electors by notices on the Council's website and in Council buildings;
 - County Councillors;
 - Parish Councils;
 - MPs;
 - Disabled/Access organisations via the Council's Equality and Diversity Officer;
 - Area Action Partnerships community groups;
 - Schools currently used as polling stations; and
 - All existing premises that are currently used as polling stations.
- 6. Officers have received a number of representations in relation to the proposals for polling stations and Members will note that many relate to schools. Some headteachers and parents have raised concerns about the proposed use of schools.
- 7. Officers have endeavoured to avoid using schools except as a last resort. This problem becomes more challenging as public buildings close and there is competition to use alternative venues, not only from the Returning Officer, but also for groups or communities running activities in buildings which could otherwise be used as polling stations.
- 8. The Returning Officer was aware of this rising difficulty and schools have been advised of all known electoral dates up to 2017 to enable headteachers, whose schools are used as polling stations, to plan their training days around this. This information is not provided as a way of directing schools to cooperate, but is intended to be helpful in circumstances where the Returning Officer's staff know that alternative venues are not practicable.
- 9. Officers have explored alternatives in cases where representations contents and the results of these explorations are within the body of the document.
- 10. On the 3 October, the Consitution Working Group approved the draft and agreed that it should be recommended to Council for adoption. It also agreed to recommend that the Head of legal and Democratic Services should have delegated authority to make changes to the polling places, if required in consultation with the Leader as Chairman of the Constitution Working Group

Recommendations and reasons

- 11. Council is asked to:-
 - Approve the polling districts and places as set out in the review;
 - Agree that the Head of legal and Democratic Services should have delegated authority to make changes to the polling places, if required in consultation with the Leader as Chairman of the Constitution Working Group

1. Review of polling districts and polling places in the Durham County Council area – Background Information and Progress to date

On 1 July 2014, the Electoral Registration Officer for Durham County Council began a review of the polling districts and polling places in the Durham County Council area. This was in respect of the duties placed upon the Council to undertake a review at this time, duties that are laid out in The Representation of the People Act 1983 as amended by the Electoral Administration Act 2006.

Having determined that a review was to take place, the Returning Officer was consulted and has made representations on existing and proposed polling arrangements. The Returning Officer's proposals were published and comments in relation to the review have also been invited from a range of consultees. These included parish councils, county councillors and political parties. Press releases were also issued. The consultation period lasted from Tuesday 1 July to Friday 29 August 2014.

The legislation requires that the consultation exercise must seek comments from people who have particular expertise in relation to access to premises or facilities for persons who have disabilities. The Council's Equalities and Diversity Officer was therefore included among the consultees.

The remaining timetable for this review is as follows:

2. The Returning Officer's Proposals

The Returning Officer noted that the pattern of polling districts and polling places in the County Council area had evolved to meet successive boundary changes and to meet the convenience of electors across the County. By and large, it ensured that electors had reasonable facilities for voting. Furthermore, in line with the Council's policies and statutory obligations, every attempt had been made to ensure that polling stations were accessible to electors who are disabled. Therefore, the proposals for change in this review have been kept to a minimum.

The Returning Officer took the following considerations into account when drawing up the proposals.

- the council must seek to ensure that all electors have such reasonable facilities for voting as are practicable in the circumstances;
- the council must seek to ensure that, so far as is reasonable and practicable, every polling place is accessible to electors who are disabled;
- every parish shall be in a separate polling district;
- ideally the polling place should be in its own polling district;
- ideally there should be no more than 2,500 electors per polling place;
- polling district boundaries should be co-terminous with existing parish ward or division boundaries;
- a polling station costs about £800 to hire, equip and staff for polling day (portable units used as polling stations can cost twice as much again to hire and maintain on the day).

3. Consultation Responses

At the beginning of the review, the Returning Officer consulted with a number of groups and individuals, including:

- Electors via notices on the council's website and in council buildings,
- County Councillors,
- Parish Councils,
- MP's.
- Disabled/ Access Organisations via the Council's Equality and Diversity Officer,
- Area Action Partnerships / Community Groups,
- Schools (only those currently used as polling stations),
- All existing premises that are currently used as polling stations

Following the close of the consultation period on 29 August 2014, several endorsements/comments had been received relating to specific polling stations which are summarized, considered and responded to in the body of the report.

Three non-specific letters were received relating to the use of schools as polling stations. The legislation relating to the use of schools as polling

stations is the Local Elections (Principal Areas) (England and Wales) Rules 2006 (SI No. 3304) which states that the Returning Officer may use, free of charge, for the purpose of taking the poll or counting the votes, a room the expense of maintaining which is payable out of any rate.

Wherever possible officers work with the schools to utilise community rooms which allow the school to remain open. However in some cases this is not possible and the school is required to close.

The consultation documents were forwarded to the Disability Partnership which includes various representations from disability groups and individuals across the county but no feedback or any queries or concerns were made.

4. The Tables

Following a summary of the proposed changes and issues arising, the polling arrangements of each parliamentary constituency will be dealt with by constituency with each county electoral division separately there after. The tables show the existing polling arrangements in each polling district:

- the polling district identity letters
- the polling place for the district
- the polling station at that place
- the number of electors per polling districts on 1 July 2014
- disabled access.

Summary of proposed changes

Following an extensive consultation process with a wide range of consultees, a number of changes to polling stations have been proposed and are summarised below:

Returning Officer's Proposals:

Following the closure of Toronto Community Centre it was necessary to site a mobile unit within the village to act as a polling station. The use of mobile units is a last resort as they provide poor accommodation as a polling station and no disabled access. However there are no alternative venues available within the village and the continued use of a mobile unit at Toronto is therefore supported.

St Peters Church Hall, Princes Street has been closed and can no longer be used as a polling station. As an emergency measure the School Room at The Elim Church was used as a polling station for the European Parliamentary election. Continued use of this venue is recommended.

The following comments/observations were received during the consultation period :

Those polling stations marked with an * have indicated that their continued use as a polling station is welcomed.

A representation from the parent of a child at St Annes CE Primary School (3123), Warwick Road has been received relating to the continued use of the school as a polling station.

This issue is not new and has been addressed previously. Whilst the use of the school and the disruption to families and education is regrettable the polling district is wholly residential and the only alternative venue is another school. As one of the principles of polling station locations is to ensure continuity for the elector it is not reasonable to alternate use between the schools. The polling district has a large electorate and often attracts a high turnout. It is

not reasonable, nor in line with legislation, when the school is available to locate a mobile unit in this area.

The representation therefore, regrettably cannot be complied with.

Recommendations to Council:

The continued use of a mobile unit for polling district BAAD, Toronto; and

The change of venue for polling district BABA to the School Room, Elim Church be approved.

Returning Officer's Proposals :

The Bridge Inn at Ramshaw closed in the run up to the European Parliamentary election and polling was moved to Ramshaw Primary School. The following comments/observations were received during the consultation period :

Those polling stations marked with an * have indicated that their continued use as a polling station is welcomed.

The Head Teacher of Timothy Hackworth Primary School submitted a request that an alternative venue be considered instead of closing the school. She suggested the former "Friends Meeting House" which is near to the school. This building is now occupied by Highlea Care, a private company. Following a discussion with Highlea Care it is apparent that the layout of the building renders it unsuitable for use as a polling station. It is also not possible to insist that a private company allow their premises to be used for polling purposes. At present there are no known alternative venues suitable for use as a polling station within the polling district.

Shildon Town Council also requested that officers consider an alternative venue to Timothy Hackworth School. Legislation indicates that a polling station should be easily accessible to electors and ideally be within the polling district. As there are no known alternative venues within this polling district officers are unable to move the polling station at this time.

A School Governor also requested that we consider alternative venues and gave examples of the Library, Council Offices and Civic Hall. None of these buildings are within the polling district and are not suitable alternatives if the Council is to comply with the requirement that polling stations be easily accessible. Moving a polling station outside of the polling district boundaries may have a detrimental impact on turnout.

Since the last review Shildon People's Centre has become fully accessible for disabled persons

The mobile unit which does not have disabled access is within a polling district where there are no other available premises. The mobile unit has been used previously without complaint.

Those polling stations marked with an * have indicated that their continued use as a polling station is welcomed.

The Head Teacher of Oxclose Nursery School has submitted comments regarding the suitability of the school as a polling station. Issues relate to the number of chairs and tables available for staff, disruption to children and families and the need to remove personal details of the children before polling day.

The Council has recently procured polling booths that are stand alone and remove the need for tables. At a recent Town Council by-election in Spennymoor there proved to be sufficient chairs for staff.

The only other suitable venue in the polling district is Oxclose Primary School and officers use the Nursery School as they have less pupils and it causes the least disruption.



The Head Teacher of Vane Road Primary School has submitted a request that the Council reconsider their use of schools as polling stations, in particular Vane Road. The reasons given are:-

- disruption to education for children
- the anomalous position at present whereby parents are fined for removing children from school for holidays yet the Council can require the school to close for polling day
- financial cost to the school in relation to the time teachers lose

Whilst we understand the issues faced by the Head Teacher and parents the Council is bound to provide a polling place for electors within the polling district.
