Mainstream primary and secondary formula funding 2017-18

Purpose of the Report

To approve the formula for distributing funding to mainstream primary and secondary schools in County Durham.

Background

- 2 Formula funding for mainstream primary and secondary schools is regulated by statutory regulation, which sets out the basis on which local authorities can allocate formula funding to these schools. This funding does not include funding in respect of early years, post-16 or special educational needs provision. The primary basis of allocation is pupil numbers, but other allocations are made in respect of deprivation and prior attainment, as well as a lump sum and premises-related factors.
- The Council consulted the Schools Forum about the formula at its meetings on 19 October and 8 December 2016 and also consulted smaller groups of members at working groups in September 2016. The Durham Association of Secondary Headteachers was consulted about a decision on the use of sparsity funding in the formula, which the Council decided not to use. The portfolio holder and his support member are members of the Forum and receive reports.
- The total funding allocated through the formula is £290,497,580 and this is allocated over 247 schools and academies. This is funded by central government through the Dedicated Schools Grant; amounts allocated to academies through the formula are then deducted from the grant, because academies are funded directly by the Education Funding Agency.
