Public Bridleway No. 31 Sedgefield Parish, Proposed Diversion and Definitive Map & Statement Modification Order

Purpose of the Report

To consider changes to the Public Rights of Way network.

Public Bridleway No. 31 Sedgefield Parish, proposed Diversion and Definitive Map and Statement Modification Order

Background

An application has been received from Mr D Brown of Town Farm to divert Public Bridleway No. 31 Sedgefield from a cross-field to a field-edge route, in the interests of agricultural efficiency, as shown on the attached plan. The proposal is therefore in the interests of the landowner. Mr Brown is now the Local Member for Sedgefield, but was not at the time of his application or the consultations.

Bridleway No.31 runs between Foxton and Stillington Moor, and currently passes across a large field east of Stillington Beck. The proposal is to divert a section of the bridleway to a more northerly line, following the field edge.

Consultations have been carried out with the Local Members, the Cabinet Portfolio Holder, Sedgefield Town Council, the Ramblers' Association, the British Horse Society and other user groups. No objections have been received.

Details of any alternative options considered and rejected when making the decision

The proposal is longer than the existing route, but within the context of a rural recreational bridleway the additional distance is not significant. Alternative routes to avoid the cross-field route would be too circuitous.

Recommendations and reasons

The proposal is in accordance with the Council's policy and the statutory framework on the diversion of public rights of way. It is RECOMMENDED that a Diversion and Definitive Map and Statement Modification Order be made under the provisions of the Highways Act 1980 and the Wildlife and Countryside Act 1981 to divert Public Bridleway No. 31 Sedgefield Parish, and the Order shall subsequently be either confirmed or referred to the Secretary of State for determination, and that the Corporate Director of Resources be informed accordingly, as per table 5, paragraph 79 of the Constitution of the County Council.
