#### Purpose of the Report

- 1 To present members of Children and Young People's Overview and Scrutiny Committee with the draft Children and Young People's strategy and consultation process for comment.

#### Background

- 2 On the 2 July 2018, the Children and Young People's Overview and Scrutiny Committee received a presentation, which provided an overview of the vision, aims and objectives of the new Children and Young People's strategy, giving members the opportunity to comment.
- 3 Stage one of the consultation has taken place throughout May, June and July which has given management teams, partnerships and children and young people the opportunity to provide feedback on the proposed vision and aims of the strategy.
- 4 Stage two of the consultation will give management teams and partnerships the opportunity to comment on the draft strategy before final sign off. The next steps for this stage of the consultation are as follows:
