Public Footpath No. 37 Durham City Withdrawal of Diversion and Definitive Map and Statement Modification Order

Purpose of the Report

To consider changes to the Public Rights of Way network.

Public Footpath No. 37 Durham City, Diversion and Definitive Map and Statement Modification Order – withdrawal of Order.

Background

On 19 May 2015 delegated authority was given to make a Diversion and Definitive Map and Statement Modification Order in respect of Public Footpath No. 37 Durham City, following an application from Durham University.

The Order was subsequently made on 25 June 2015 and advertised in accordance with statutory provisions. No objections were received, but as the development progressed minor amendments meant that there was no longer a need to divert the Public Footpath.

The applicant is happy that the Order is no longer required and that it can be withdrawn.

Details of any alternative options considered and rejected when making the decision

As the original path is still in place there is no need for a Diversion and Definitive Map and Statement Modification Order. The Order cannot be abandoned without a formal decision to withdraw it.

Recommendations and reasons

The proposal is in accordance with the Council's policy and the statutory framework on the diversion of public rights of way. It is RECOMMENDED that The County Council of Durham (Public Footpath No.37 Durham City) Public Path Diversion and Definitive Map and Statement Modification Order 2015 be withdrawn under the provisions of the Town and Country Planning Act 1990 and the Wildlife and Countryside Act 1981, and that the Corporate Director of Resources be informed accordingly, as per paragraph 77 of the Constitution of the County Council.
